BOOTHS: Your booth must be designed to withstand wind and inclement weather and your displays adjustable to surface grade. You are responsible for supplying your own canopy, table, chairs, carpet, etc. Power IS NOT included in booth fees, but is available for \$35. A maximum of 30amps-125 volt outlet (1) or 20amp-125 volt (2) is available per booth (see attached photo). You must supply at least 50ft. of heavy duty extension cord and adapters for hook-up to power source. IF YOUR ELECTRICAL NEEDS ARE DIFFERENT THAN WHAT IS DESCRIBED, YOU MUST CONTACT RCR PRIOR TO SUBMITTING YOUR APPLICATION. No refunds for cancellation or no shows after approval of your application.

SECURITY: The event maintains security; however we accept no responsibility for loss or damage.

PERMITS: A copy of your sales tax license and food service license (also non-profit) must be submitted with your application or your application will NOT be approved.

INSURANCE: All vendors including non-profit must supply River City Racine' with a Certificate of Insurance of General Liability with Products Liability listing River City Racine' as additional insured. This must be included at the time of application or your application will NOT be approved.
